EDUCATION SCHOLARSHIP PROGRAM

Beach Municipal FCU strongly believes in giving back to the community and its members, which is why we are excited to once again share with you two different scholarship programs.

BEACH MUNICIPAL FEDERAL CREDIT UNION 2023 EDUCATION SCHOLARSHIP PROGRAM

Each year, your Credit Union offers two \$2,500 education scholarships to students who are members of the Credit Union.

Applicants may fall into one of two categories:

- Graduating high school senior (or equivalent) who has been accepted to and will attend an accredited college, university or trade school after graduation.
- Currently enrolled undergraduate student in good standing of an accredited college, university or trade school.

To be eligible for this scholarship program, applicants must:

- Be no older than 23 years of age at time of application
- Be a member of Beach Municipal Federal Credit Union for a minimum of six months with an account in good standing prior to application (joint owner status does not qualify)
- Have a minimum grade point average of 3.0 on a 4.0 scale or equivalent as of March 31, 2023, or as of the most current official transcript
- Complete a scholarship application
- Submit three letters of recommendation and copies of SAT/ACT scores
- Submit an original essay of no less than 700 words and no more than 750 words on the topic of "Describe a personal accomplishment and the strengths and skills you used to achieve it."

Applications with full details and requirements will be available at each Beach Municipal FCU branch beginning February 1, 2023. Application packets must be completed in their entirety and returned to the Credit Union by the close of business, April 18, 2023. Any incomplete applications will be disqualified. All applications and essays become the property of Beach Municipal Federal Credit Union and will not be returned. Selected applicants will be notified by May 15, 2023.

THE LEIGH ANN GRAHAM SCHOLARSHIP

The Tidewater Chapter of the Virginia Credit Union League offers the Leigh Ann Graham Scholarship to qualified graduating seniors who plan to attend a college or university. Several \$1,000 scholarships are awarded.

To be eligible for this scholarship program, applicants must:

- Be graduating seniors
- Be members of a credit union in the Tidewater Chapter of Credit Unions
- Be in need of financial assistance and must have applied to a college or university
- Submit a completed scholarship application packet with high school transcripts by the deadline date of April 19, 2023

Applicants will be selected on the basis of scholastic achievement, character and leadership, essay responses and financial need. Entries must be postmarked by **April 19, 2023**. Please visit our website or stop by a branch for an application.

The Tidewater Chapter of the Virginia Credit Union League has renamed their scholarship after Leigh Ann Graham who recently retired from Beach Municipal FCU after serving many years as our Vice President of Mortgages. Since 2002, she has devoted countless hours to the Chapter and the overall credit union movement. Among her many successes is the Chapter's annual



charity golf tournament which has raised more than \$136,300 for CHKD. During her tenure, more than \$180,000 has been awarded in scholarships to help area credit union members pursue their educational dreams. To recognize her extraordinary service to the Chapter, the Chapter has renamed the scholarship program in her honor.

Be sure to save your December 2022 statement for tax purposes. It contains year-end totals of dividends earned on shares and interest paid on loans. You will only receive a 1099 if you earned \$10 or more in dividends in 2022, and you will receive a 1098 only if you paid \$600 or more in mortgage interest.

Now that the holiday season is over, it's time to think about taxes. Contributing to an IRA may lower your taxable income and save you money. As of 2022, the maximum limit for your annual contribution is \$6,000 for qualified owners, and individuals 50 and older may contribute an additional \$1,000 maximum per year.

The deadline for your 2022 contribution is April 18, 2023. If you have been thinking of opening a Traditional or Roth IRA, we have information available to help you and your financial advisor decide which option is the most beneficial for your financial needs.
